Dear Sir or Madam,

Enclosed please find a copy of the check for \$150. We respectfully request abatement of the reinstatement penalty. We changed our mailing address and it wasn't until we were sitting with our accountant on April 30 that we realized we had not yet filed our UBR for 2000.

We filled in a blank form, our accountant wrote the check for us, and we mailed it on that day. We assume the requirement is a postmark on April 30, and we are certain it was postmarked that day.

A representative from the state explained to us our corporation was dissolved because the \$400 penalty was not paid. She explained that the form was returned to us for the reinstatement penalty of \$400 because of late filing. We think the form was mailed to the old address once again, because we never received the request for the penalty and the state never received or filed our form. If the form was returned to us, we would have at least requested abatement of the penalty at that time, and we would have done whatever necessary to avoid the corporation's being dissolved.

And when the form is returned, the original check is returned as well, and that check was never returned. That check was processed by the Dept. of State on May 19, and then it cleared the bank on June 13.

We respectfully request abatement of the penalties assessed, our report will be filed timely in the future.
