Pursuant to the provisions of Section 607.1006, Florida Statutes, Toral Garcia Pineyro & Franz P.A., a Florida professional service corporation (the "Corporation"), document number P95000079065 that filed its Articles of Incorporation with the Florida Department of State on October 13, 1995, hereby adopts the following amendment to its Articles of Incorporation:

FIRST: The Corporation's Articles of Incorporation are hereby amended by deleting Article I in its entirety and inserting a new Article I to read as follows:
