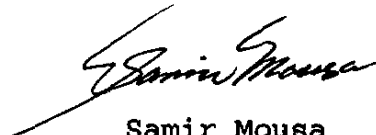

We advised him that we never received an Annual Report for 1996 at our business address nor our home address and that is the reason the Annual Report was never filed.
