The Articles of Incorporation of D & S Aircraft Tool and Products, Inc., a Florida corporation, are amended as set forth in these Articles of Amendment:

1. The name of this corporation, until amended as provided herein, is D & S Aircraft Tool and Products, Inc.
2. The Articles of Incorporation of this corporation are amended by changing the name of the corporation from D & S Aircraft Tool and Products, Inc. to D & S Camshaft Corporation.
3. The text of the amendment adopted is as follows: "The name of this corporation is D & S Camshaft Corporation."
4. This amendment was adopted by the directors and shareholders of this corporation on November 2, 1998, and the number of votes cast for the amendment by the shareholders was sufficient for approval.
5. This amendment is made pursuant to Sections 607.1003 and 607.1006, Florida Statutes.
6. This amendment is effective immediately upon being filed with the Florida Department of State.
