The Articles of Amendment of this corporation are hereby amended as follows:

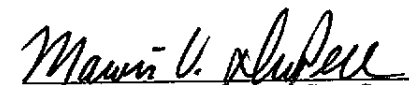
1. Article I is hereby amended to read as follows:

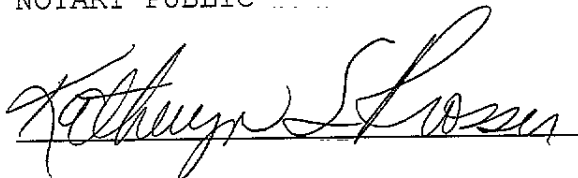

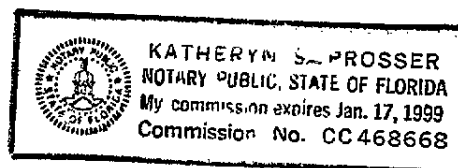

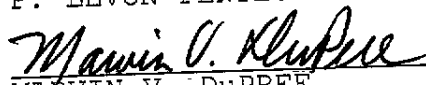
