ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION

OF STAFF FORCE OF BROWARD, INC.

The Board of Directors and all Shareholders of STAFF FORCE OF BROWARD, INC., at a meeting duly called and conducted at 3.00 p.m. the 30 day of November, 1998, at 2260 lalm Beach Lakes Blud, West kinded, fc, adopted the following:
The corporation, STAFF FORCE OF BROWARD, INC., shall increase its maximum number of shares the corporation is authorized to have outstanding at any one time from 1,000 shares of common stock to 1,235 shares of common stock, and therefore amending its Articles of Incorporation at Article III, as follows:
ARTICLE III Capital Stock
The maximum number of shares this corporation is authorized to have outstanding at any one time is 1,235 shares of common stock with a par value of one dollar (\$1.00) per share.
The above amendment was approved by the Directors and Shareholders entitled to vote on the amendment, the Directors and Shareholders being Sandra K. Murphy, Robert P. Murphy and Jean Laukhuf, who hold all of the shares of the corporation and who voted unanimously for the adoption of this amendment changing the maximum authorized shares of stock from 1,000 to 1,235 shares of common stock.
