Enclosed is the 1999 Profit Corporation Annual Report for the above Florida corporation and a check in the amount of \$150 for the annual fee.

We are aware that this report is delinquent. We did receive the Application for Reinstatement. However, we are respectfully requesting that the fee for the reinstatement be abated due to reasonable cause.

The owner of the corporation is a resident of Puerto Rico. Due to certain business hardships in his Puerto Rico company, he was unable to spend the appropriate amount of time in Florida to manage the Florida business. Many administrative matters slipped through the cracks in 1999 which we are trying to resolve now.
