Dear Ms. Cushing:

This letter is in response to your letter of July 7, 1999 regarding the active registration of ASCI Computer, Inc. to complete the registration of the above-referenced trademark. Also, this letter is to request that the \$600.00 reinstatement fee to activate ASCI Computer, Inc. be waived due to an error in the mailing address listed on the Corporate Detail Record Screen enclosed with your July 7, 1999 letter.

My client and president of ASCI Computer, Inc., Clifford Skeete, never received notice of his annual fees being due or of the dissolution of his corporation because of said error on the part of the Division of Corporations. Please note that the mailing address denoted in your records for ASCI Computer, Inc. in the above-referenced matter was, "% A A Ali, CPA, Orlando, FL 32810", an invalid address for ASCI Computer, Inc. In fact, the absence of a street address or post office box address means the address is invalid according to U.S. Postal Services.

This error was confirmed by my legal assistant, Jennifer Birkrem, with your employee, Tyrone on July 16, 1999. Tyrone verified and confirmed that the Division of Corporations maintained an invalid mailing address in its computer. He then advised my legal assistant to send him a letter requesting a waiver of the
