ARTICLES OF AMENDMENT

TO

ARTICLES OF INCORPORATION

OF

NATURE COAST INDUSTRIES, INC.

FIRST. The name of the corporation is Nature Coast Industries, Inc. (the "Corporation")

SECOND. Section 3 of the Articles of Incorporation of the Corporation is hereby deleted in its entirety and replaced by the following new Section 3:

"3. Stock. The maximum number and class of shares of capital stock this Corporation is authorized to have outstanding is 1,000,000 shares of common capital stock of a par value of \$0.01 per share. The Corporation shall have a lien on its shares of stock for any debt or liability incurred to it by a shareholder before being notified of the transfer or levy on such shares."

THIRD: The amendment was adopted by unanimous written consent of the Board of Directors of the Corporation and unanimous written consent of the holders of the outstanding shares of the voting capital stock of the Corporation. The number of shareholder votes cast for the amendment was sufficient for approval.
