**ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION  
OF  
PTT TELEKOM, INC.**

Pursuant to the provisions of Section 607.1006, Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

**FIRST:** Amendment adopted:

**ARTICLE IV - CAPITAL STOCK**

This corporation is authorized to issue one hundred thousand (100,000) shares of voting common stock, having no par value per share and one hundred thousand (100,000) shares of non-voting common stock, having no par value per share.

**SECOND:** The date of Amendment's adoption: MARCH 11, 1998.
