Reference No. P 95000083493 Dear Sirs/Madams Recently, I was talking to an associate of mine who is the principal of his own corporation. He was complaining to me that he had missed the filing deadline for the annual report for his corporation, and he said that this year the penalty for late filing was greatly increased over the previous year.

This conversation caused me to remember that I had never received the annual report packet from the Department of State. I telephoned the Division of Corporations and requested an annual reporting form which I received in blank and which I return herein with a filing fee of \$165.00.

I request a wavier of any penalty for late filing for the reason that I never received the annual report form from the Division of Corporations, and I had to request it myself. Had I received the annual report packet in a timely fashion, I would have filled out the report and returned it with the filing fee prior to May 1, 1997. Do you have any evidence that the report was mailed to me? I think not. Incidentally, on Friday, July 18, 1997, you did receive a report packet, but it was marked "second notice."

Something somewhat analogous occurred last year. What occurred last year had to do with my failure to receive notice of the final deadline for filing the annual report before a corporation is placed on inactive status. The Division of Corporations could not produce evidence of such notice to me even though the notice was allegedly by certified mail. I requested a waiver of any penalty for a late filing last year, by correspondence dated October 10,

· 1996, and because I never heard anything to the contrary, I assume that the penalty for late filing was waived for last year. This year I did not even receive the annual report form to file in the first place.

Once again, I never received any notification with respect to the filing of an annual report. Furthermore, when I did request an annual report form, why was one sent to me in blank? Why was not the form preprinted with the information the Division of Corporations already has about my corporation?

Please respond to me concerning this matter so that I will know that steps have been taken to prevent this from reoccurring in the future. Otherwise, I fear that this mistake will reoccur perpetually with me having to request a waiver each and every year.
