The above captioned taxpayer has requested that we write to you regarding the \$600 reinstatement penalty imposed as a result of an administrative dissolution of the Corporation.

Please note that it was not the taxpayer's willful neglect or intent to not file and pay the Florida Corporate Annual Report ("Report") but simply a result of facts to be stated below.

The taxpayer does not have a sophisticated system of accounting and also does not have knowledge of all tax and other annual filings required under federal and Florida law. As a result, the taxpayer forwards all mail to his accountant and depends on the accountant for instructions as to what filings or payments are required.

During the 1998 calendar year, the taxpayer relocated its business to Broward County and accordingly had its mail forwarded to the new address (2359 S. State Road 7, Broward County, Florida). After the move, the taxpayer did have instances where mail that was expected was not received. As a result, it is the taxpayer's belief that the Reports were mailed to the old address and never forwarded to the new address.

At all times it was the taxpayer's belief that they were compliant with all filing requirements until the taxpayer's bank gave notice that the Companywas not an active Florida corporation. Upon such notice the taxpayer verified the information with the accountant and Florida to further conclude that the Reports were never received and filed.

In light of the above facts, we respectfully request thatall penalties be abated. Enclosed please find the completed Report and a check in the amount of \$300 for the 1999 and 2000 annual fee.
