The undersigned submits to the Florida Secretary of State the Articles of Amendment to the Articles of Incorporation of ADVANCED MAGNET LAB, INC.

ARTICLE I. The name of the corporation is Advanced Magnet Lab, Inc.

ARTICLE II. The Articles of Amendment were adopted on the 7th day of July, 2008.

ARTICLE III. ARTICLE IV of the Articles of Incorporation is deleted in its entirety and replaced with the following:


ARTICLE IV

Capital Stock

This Corporation is authorized to issue one hundred million (100,000,000) shares of common stock with a par value of one-tenth of one cent (\$0.001) per share.
