Pursuant to the provisions of Sections 607.1003, and 607.1006, Florida Statutes, the undersigned Shareholders adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is DACOS U.S.A., INC.

2. The following Amendments to the Articles of Incorporation were adopted by the unanimous vote of the Shareholder of the corporation on November 20, 1996, in the manner prescribed by the Florida General Corporation Act:

## ARTICLE I. - NAME

The name shall be amended to be: FIREBAN CORP.

3. The number of Shares of the Corporation outstanding at the time of such adoption was five hundred (500); and the numbers of Shares entitled to vote thereon was five hundred (500).
