Pursuant to the provisions of Sections 607.1003, and 607.1006, Florida Statutes, the undersigned Shareholders adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is FIREBAN CORP.
2. The following Amendments to the Articles of Incorporation were adopted by the unanimous vote of the Shareholders of the corporation on March 18, 1999, in the manner prescribed by the Florida General Corporation Act:
