Dear Reader:

On March 1, 1996 we took over BENEDADE, INC., BENESAWGRASS, INC. and BENESOUTHBEACH, INC. moving the office from 1101 Brickell Avenue, Suite 1103, Miami, Florida 33131 to 1200 Wisconsin Avenue, N. W. Washington D. C. 20007., in order to reduce expenses from these companies in financial difficulties.

During this transition we concentrate our efforts in paying existing liabilities, payroll and taxes, with the reluctant cooperation of the office employee that were aware of the future closing of the local Office.

We were not familiar with all the Florida laws, and we did not maintain on file with the Secretary of State the current addresses of these corporations, consequently, we did not file the required annual reports.

I am enclosing checks for \$665.00 plus the \$8.75 additional fee required for a Certificate of Status or the total of \$673.75 for each company, and requesting the abatement of any penalties that the omission of the annual report has caused.
