ARTICLES OF AMENDMENT PURSUANT TO REORGANIZATION

Sensational Entertainment Xtravaganza, Inc. hereby amends its articles of incorporation, pursuant to § 607.1008, Fla. Stat. (2001).

The name of the corporation is Sensational Entertainment Xtravaganza, Inc.

Sensational Entertainment Xtravaganza, Inc. is the Chapter 11 debtor in case number 01-02817-6B1 in the United States Bankruptcy Court for the Middle District of Florida, Orlando Division. Article VI, section 6.01 of the plan of reorganization provides that

On or before the effective date, the reorganized debtor will amend its articles of incorporation to prohibit the issuance of nonvoting securities.

This plan provision is mandated by 11 U.S.C. § 1123(a)(6). The effective date of the plan was January 28, 2002.

The plan was confirmed by order dated January 15, 2002.
