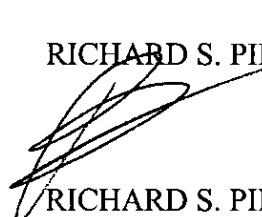
Enclosed is a Corporation Reinstatement form for Gilder Funding Corp., along with a check in the amount of \$150.00, representing the reinstatement fee.
