To Whom It May Concern:

I received your notice of administrative dissolution or revocation package in the mail last Friday, October 12, 2001. I left on a business trip to Toronto on Saturday, October 13, 2001 and returned yesterday. Today, I read the package you sent to our company and called your offices to understand why I received this notification.

I am the Founder, Chairman and CEO of Decade Systems Corporation. I personally signed each annual renewal from 1996 through 2000. In June of year 2000 I sold the company to a client in Ft. Lauderdale, Florida. All record keeping was transferred to the parent company OnLoan.com, a Florida corporation. All personnel, financial, and administrative record keeping was transferred to the Ft. Lauderdale operation and any mail, invoices, and legal documents received here in Ponte Vedra was forwarded to the Ft. Lauderdale offices. Although I do not recall specifically dealing with the year 2001 renewal, I am certain that it was sent along with the other administrative materials in my regular weekly Federal Express packages to the Ft. Lauderdale facilities.

Late in year 2000 OnLoan.com ran into financial difficulties like many other of the dot com companies. In the spring of 2001 I decided to reacquire my company, Decade Systems Corporation in order to save it from failing along with OnLoan.com. We officially regained control of the company in April with the final check to the owners and investors on May 4, 2001. Although we performed our due diligence related to financial records, we did not discover the State of Florida Corporation renewal until I received your notice of dissolution.

I am proud to be a Florida Corporation and proud to have saved it from it's interim owners. We are in the process of restoring our company to be financially sound. It was suggested I write a letter to explain how this item fell through the cracks at Decade Systems Corporation. I am sending my \$150.00 annual renewal check along with this letter in the hope that you will restate us to an active and current status.
