The undersigned corporation adopts the following Amendment to its Articles of Incorporation pursuant to Section 607.1006 Florida Statutes (1993):

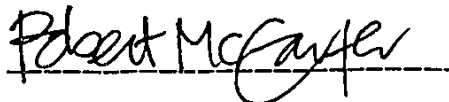
1. The name of the corporation is D.Mc<sup>2</sup> ARCHITECTS, P.A.
