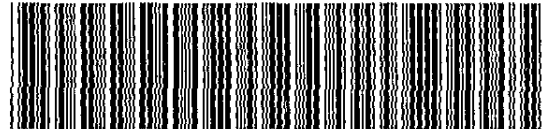

THIRD: The dissolution was approved by the shareholders. The number of votes cast for dissolution was sufficient for approval.


FOURTH: The effective date of the dissolution shall be December 31, 2005.
