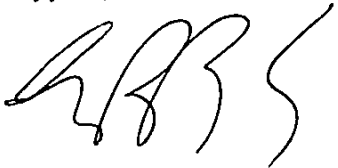

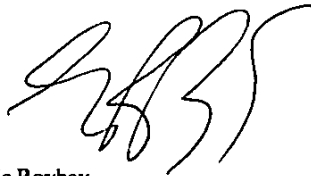

1. The Articles of Incorporation for 3D Com, Inc. were filed on November 15, 1995, and assigned document number P95000087984.

2. Article III of the Articles of Incorporation of 3D Com, Inc. is hereby amended to read as follows:

ARTICLE III  
Capital Stock

The maximum number of shares of stock that the corporation is authorized to have outstanding at any one time is: 1000 shares.

3. The foregoing Amendment was approved by a majority vote of the shareholders, and the number of votes cast by the shareholders was sufficient for approval. It was adopted by the corporation on August 3, 1997.

4. The effective date of this Amendment shall be that of the filing of these Articles of Amendment.
