ARTICLE VI - BOARD OF DIRECTORS

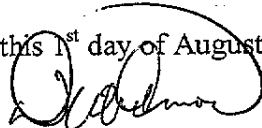

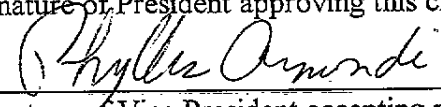
SECOND: The amendment is not providing for any exchange, reclass, or cancellation of issued shares.
