OF

AMTRADE INTERNATIONAL, INC., a Florida corporation (the surging corporation), joined by AMTRADE SERVICES, INC., a North Carolina corporation (the absorbed corporation), qualified to do business in the State of Florida as a foreign corporation, adopt and file the following articles as their Articles of Merger:
