They have fraudulently changed our registered agent and have tried to say we authorized the transaction through a telephone authorization. I am very concerned for our fellow contractors who are being swindled by these people.

I called this Company when a charge appeared on my credit card for an extra \$150. I called on July 5th and that is when I was told it was for the registered agent service. The guy told me I had given telephone authorization for this service. I told him, I knew what a registered agent is and that I would have never knowingly given authority for them to be the agent. He said they had telephone records, and I requested to hear the call, he took my number and said they would call. I did not get his name. When he did not call, I called again on July 6th and spoke with Noel, she is the telephone records are on David Santiago's computer and he was not in, but she would have me call him me when he returned. He did not call, so I called again on July 9, (Monday) and spoke with Noel, who then said she or David Santiago would call me back. Noel called back and said they had met and that they would not provide me with the recording of the call. I told her I had disbuted the charge on my credit card and I had sent a letter to the Department of the State Division of Corporations on July 6th. She asked me to fax her a copy of that letter and I did. Today on August 1st I look on-line and they have changed my registered agent and it is dated July 9th, after I had already made three calls objecting to the service on July 5, 6th and 9th they still proceeded the information.
