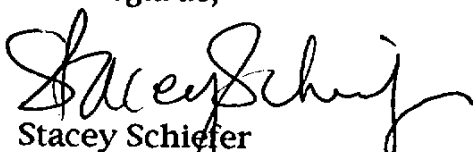
I am returning the documents you returned to me for the following reasons:
