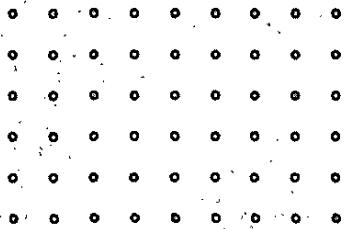


Gentlemen and ladies,
