Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act (the "Act"), the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the corporation is SUMMIT OF THE AMERICAS COUNCIL, INC. (the "Corporation"), Charter #0P9500090868, filed on November 29, 1995.
- 2.
