Last month I sent in our Annual Report along with a check for \$165.00. It was late, and both my report and check were returned along with a letter (ref# P95000091175) requesting an additional \$385.00 late filing fee. I understand the reasoning behind a late fee but one that is more than double the original fee is extremely harsh, particularly for a tiny business like ours.

The reason we filed late was because we never received the original form in the first place. We found out about our mistake when a friend told us that we had already missed the date. We have been in business a short time so are not familiar with what is due when. I called your office to request a form, that was promptly sent. The person I spoke to even told me not to worry about the penalty and to simply send the \$165.00 with the Annual Report.

If possible I would like to request that the late fee be reduced to a more reasonable sum. Or at least have a reasonable payment plan established. Our business is only part time to supplement regular salaries so it will not be worth our while to continue if we have to come up with \$500.00 all at once.

I also would like to know who to contact in government to find out why such a large late fee has been established. I would like to write them and request that this rule be changed so that a more modest fine is charged.
