



(A Florida Corporation)

Pursuant to the provisions of Section 607.1007 of the Florida Business Corporation Act, the undersigned hereby adopts the following Amended and Restated Articles of Incorporation:

- The name of the corporation is ROLLING SHIELD PARTS, INC. (the "Corporation"). The date of filing the original Articles of Incorporation with the Secretary of State was November 30, 1995, as further amended. The document number assigned to the Corporation by the Florida Department of State is No.: P95000091259.
- The Amended and Restated Articles of Incorporation were unanimously adopted and approved by all of the members of the Board of Directors and the sole Shareholder of the Corporation on February 17, 2023 in accordance with Sections 607.1003, 607.1006, and 607.1007 of the Florida Business Corporation Act.

Any amendment, repeal, or modification of this Article VII shall not adversely affect any right or protection hereunder of any person in respect of any act or omission occurring prior to the time of such repeal or modification.
