ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF RON SACHS COMMUNICATIONS, INC.

Pursuant to the provisions of Section 607.1006, Florida Statutes, RON, SACHS COMMUNICATIONS, INC., a Florida corporation, adopts the following Articles of Amendment to its Articles of Incorporation:

1. Article III, Capital Stock, is amended to read:

ARTICLE III Stock

The authorized capital stock of this Corporation shall consist of ten thousand (10,000) shares of common stock with a par value of One Dollar (\$1.00) per share.
