ARTICLES OF INCORPORATION OF  
RON SACHS COMMUNICATIONS, INC.**

Pursuant to the provisions of Section 607.1006, Florida Statutes, **RON SACHS COMMUNICATIONS, INC.**, a Florida corporation, adopts the following Articles of Amendment to its Articles of Incorporation:

1. Article III, Capital Stock, is amended to read:


**ARTICLE III  
Stock**

The authorized capital stock of this Corporation shall consist of ten thousand (10,000) shares of common stock with a par value of One Dollar (\$1.00) per share. The stock of the Corporation shall be issued for such consideration as may be determined by the Board of Directors, but not less than par value. Shareholders may enter into agreements with the Corporation or with each other to control or restrict the transfer of stock and such agreements may take the form of options, rights of first refusal, buy and sell agreements, or any other lawful form of agreements.

2. Articles IV, Shareholders, is hereby deleted in its entirety.
3. Pursuant to Sections 607.1001, 607.1002, 607.1003, and 607.1006, Florida Statutes, and in accordance with the Articles of Incorporation of the Corporation, the sole Shareholder authorized and consented in writing on March 14<sup>th</sup>, 2006, to the filing of these Articles of Amendment to the Articles of Incorporation, and his vote was sufficient for approval.
