

**ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION OF  
RON SACHS COMMUNICATIONS, INC.**

Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida profit corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. Article I of the Articles of Incorporation as subsequently amended is amended to read:

**ARTICLE I**

*The name of the corporation shall be **Sachs Media Group, Inc.***

2. Pursuant to Sections 607.1003, 607.1004, and 607.1006, Florida Statutes, and in accordance with the Articles of Incorporation of the Corporation, the Shareholders holding not less than a majority of the shares of the Corporation's common stock authorized and consented in writing on February 13, 2013, to the filing of these Articles of Amendment to Articles of Incorporation, as amended March 21, 2006. The majority vote of Shareholders was sufficient for approval.
