ARTICLES OF AMENDMENT OF ICS GROUP, INC.

ICS Group, Inc., a Florida for profit corporation, pursuant to the provisions of Florida Statutes § 607.1006, hereby adopts the following Articles of Amendment to ICS Group, Inc.'s Articles of Incorporation:

- 1. The name of the corporation adopting and filing these Articles of Amendment is ICS Group, Inc., Document Number P95000092059.
- 2. The following amendments to the Articles of Incorporation of ICS Group, Inc. were unanimously adopted by the Board of Directors of ICS Group, Inc. on March 14, 2002:

ARTICLE IV

The Corporation has the authority to issue One Thousand (1,000) shares of voting common stock with a par value of One Dollar (\$1.00) per share. The Corporation shall have no other classes of shares of stock.
