
Dear Department of State:

This is a request for abatement of the fee for reinstatement for the Vicente Salas & Sons Investment Co. EIN #77-0458050. The mailing address to which you mailed the corporation annual report form was incorrect. You apparently mailed the form to 612 Hibiscus Drive, Hallandale, FL 33009. The correct mailing address for the corporation is 1671 S. Wolfe Rd., Sunnyvale, CA 94087. Enclosed is a copy of some correspondence from the Florida Department of Revenue dated 10/02/97 which is addressed to the correct address. The president of the corporation never received the annual report form for the corporation from your office, and therefore could not file. It is only now that the officers of the corporation have been advised that forms are mailed out in December of each year, and should expect it then.
