ARTICLES OF AMENDMENT TO

ARTICLES OF INCORPORATION

- 1. The name of the corporation (the "Corporation") is PRECISION REPROGRAPHICS, INC.
- 2. The Articles of Incorporation of the Corporation are hereby amended to change the name of the Corporation from PRECISION REPROGRAPHICS, INC. to A.E.C. COPIES, INC.
