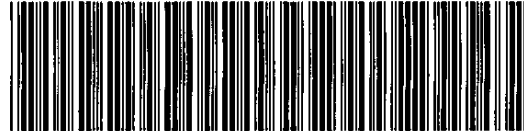


1. The name of the corporation is **CENTERPIN TECHNOLOGY, INC.**.

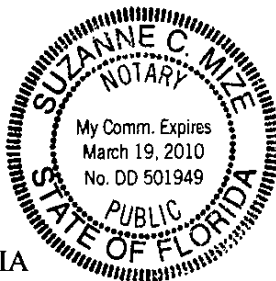

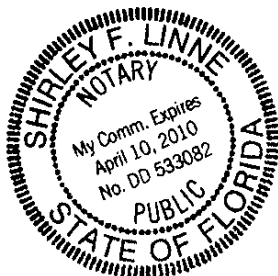


