AMENDED AND RESTATED
ARTICLES OF INCORPORATION
OF

The undersigned, Mark Sustana, being a duly elected Vice President of SILVER LAKES-GATEWAY CLUBHOUSE, INC., a Florida corporation (the "Corporation"), hereby states as follows on behalf of the Corporation:

1. The Articles of Incorporation of the Corporation (the "Articles") were filed with the Secretary of State of the State of Florida (the "Secretary") on December 8, 1995, as Document No. P95000093061.

2. Pursuant to the requirements of Sections 607.1006 and 607.1007 of the Florida Business Corporation Act, the undersigned hereby certifies, attests and serves notice that the Articles of the Corporation are hereby amended and restated in their entirety to read as follows effective as of 12:01 A.M., on June 21, 2006, which Amended and Restated Articles of Incorporation incorporate amendments to all articles of the Articles of the Corporation:

ARTICLE I -- NAME

The name of this corporation is SILVER LAKES-GATEWAY CLUBHOUSE, INC. (the "Corporation").

ARTICLE II -- PRINCIPAL OFFICE AND MAILING ADDRESS

ARTICLE III -- PURPOSE

This Corporation is organized for the purpose of transacting any or all lawful business.
