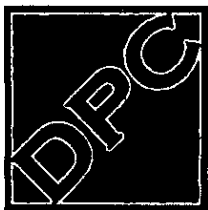

To whom it may concern:

On Friday December 21, 2001 I spoke with one of your agents and explained the reason why Domenico's Pizza Company (Document #P95000093356) failed to file their 2001 Corporation Annual Report in a timely manner. Your agent told me to file the re-instatement application and put in writing the reasons for filing at such a late date.

For the past 6 years our accountant always handled all of our renewal reports and licenses and would just have me sign them and he would take care of the payment and mailing. Unfortunately about a year and a half ago our original accountant passed away very suddenly. His business was purchased and the new owner took over late in the fiscal year 2000. At that point we had no choice but to trust him.

About 2 months ago his incompetence could no longer be tolerated and I fired him. We later learned of some personal problems that he had been dealing with. We are now finding out all of the matters that he neglected and are trying to resolve them in a timely manner.

On Monday December 17, 2001 we found another box of bills and paperwork that he never handled. While going through the box on Thursday December 20, 2001 I found the notice of Administrative Dissolution from your office. This was the first notice I saw regarding this matter.

I have filled out the Application for Re-instatement and mailed it back with a check for \$150.00 as your agent told me to do. I would like you to consider waving the re-instatement fee of \$600.00 due to my lack of knowledge of the other notices by reason of a problem that was out of my control.
