Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, the Articles of Incorporation of OSHEROFF-WITTELS FAMILY CORP. (the "Corporation") as originally filed on December 7, 1995, under document no. P95000093412, as amended, are hereby amended according to these Articles of Amendment:

FIRST: Article I and Article II of the Articles of Incorporation of the Corporation are hereby amended to read as follows:

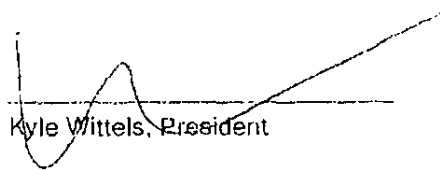
ARTICLE I. The name of the corporation is: WITTELS FAMILY CORP.
