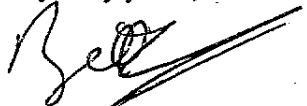

ARTICLE I of said Articles of Incorporation which presently reads:

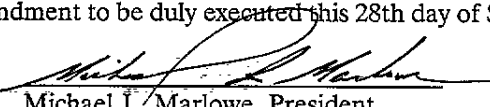
"The name of this corporation shall be MARLOWE,
APPLETON, WEATHERFORD & SALZMAN, P.A."

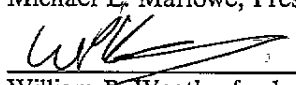
shall be amended to read as follows:
