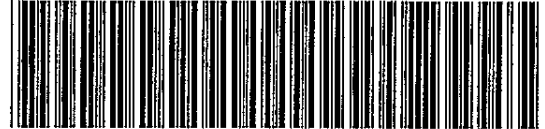

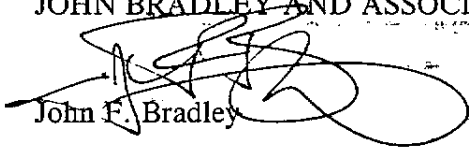

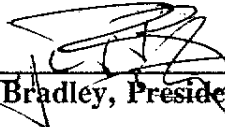
FOURTH: John F. Bradley is the sole officer, director and shareholder of the corporation.

SIXTH: The amendment was approved by all of the officers directors and shareholders of the corporation on the 1st day of Nov, 2004, after a Shareholder Meeting.

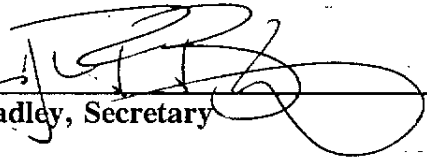
