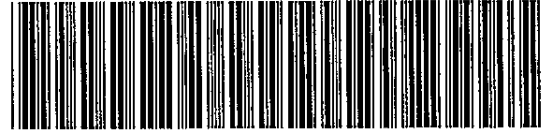

*Digital Studio Techniques, Inc.*


SECOND: There is no reclassification, exchange or cancellation of existing shares.

A special meeting of the Board of Directors of Mac Design Magazine, Inc. was held on April 14, 2004 at the corporate offices in Oldsmar, FL.



All Directors agreed the name should be changed. All Directors agreed to the name offered by Jean Kendra.


RESOLVED, that commencing April 14, 2004 the name of the company will be changed from Mac Design Magazine, Inc. to Digital Studio Techniques, Inc.


It is further authorized that the appropriate procedures be undertaken to change the name with the State of Florida, the Internal Revenue Service and the proper banking institutions.
