The new registered office of the corporation is 2069 Tocobaga Lane, Nokomis, Florida, 34275.



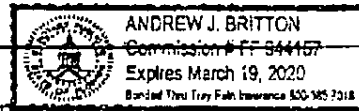
