

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF JAMES D. A. HOLLEY & CO., P.A.

OBOKC 3 24 1:06

Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida professional services corporation adopts the following Articles of Amendments to its Articles of Incorporation:
