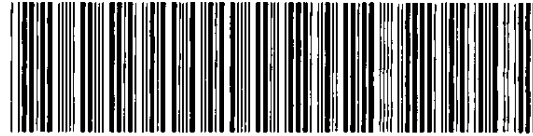

Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida professional services corporation adopts the following Articles of Amendments to its Articles of Incorporation:

1. Article I of the Articles of Incorporation is amended to read:

ARTICLE I. *The name of this Corporation shall be **JDAH, INC.***

2.
