1. The current name of the corporation is Sharon L. Wilf, Inc.

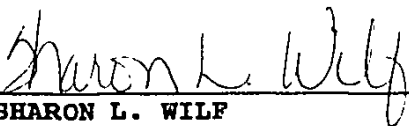
