

ARTICLES OF AMENDMENT TO THE ARTICLES
OF INCORPORATION
OF

Pursuant to the provisions of Section 607.181 of the Florida General Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is ADVANCED BUSINESS COMMUNICATIONS, INC.
2. The following amendment of the Articles of Incorporation was adopted by the shareholders and directors of the corporation on February 9, 2000, in the manner prescribed by the Florida General Corporation Act:

ARTICLE I is amended by changing the name of the corporation from "ADVANCED BUSINESS COMMUNICATIONS, INC." to "FIBER-NET, INC..", so that ARTICLE I shall now read: "The name of the corporation shall be: "FIBER-NET, INC."
3. The number of shares of the corporation outstanding at the time of adoption was 100, and the number of shares entitled to vote thereon was 100.
4. The number of shares voted in favor of such amendment was 100, and the number of shares voted against such amendment was -0-.
5. Such amendment does not effect a change in the amount of stated capital.
