Pursuant to the provisions of Section 607.1107 and 607.1109 of the Florida Business Corporation Act, the undersigned business entities do hereby make and execute these Articles of Merger for the purpose of merging GMH Realty, Inc., a Delaware corporation, into College Park Management, Inc., a Florida corporation (the "Merger"):

(a) The Agreement and Plan of Merger is as follows:

1. The name of each corporation to be merged is GMH Realty, Inc., a Delaware corporation, and College Park Management, Inc., a Florida corporation. The name of the surviving corporation is College Park Management, Inc.

2. At the time the Merger is effective (the "Effective Time"), each issued and outstanding share of common stock of GMH Realty, Inc. shall be converted into \$.10 and canceled and extinguished by virtue of the merger and without any action by the holder thereof.

(b) The Effective Date of the Merger shall be the date of the filing of these Articles of Merger.

(c) The date of adoption of the Agreement and Plan of Merger by the shareholders of GMH Realty, Inc. was October 1, 2001.

(d) The date of adoption of the Agreement and Plan of Merger by the shareholders of College Park Management, Inc. was October 1, 2001.
