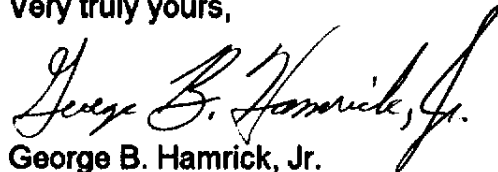
Dear Ms. Bartlett:
